Executive Summary

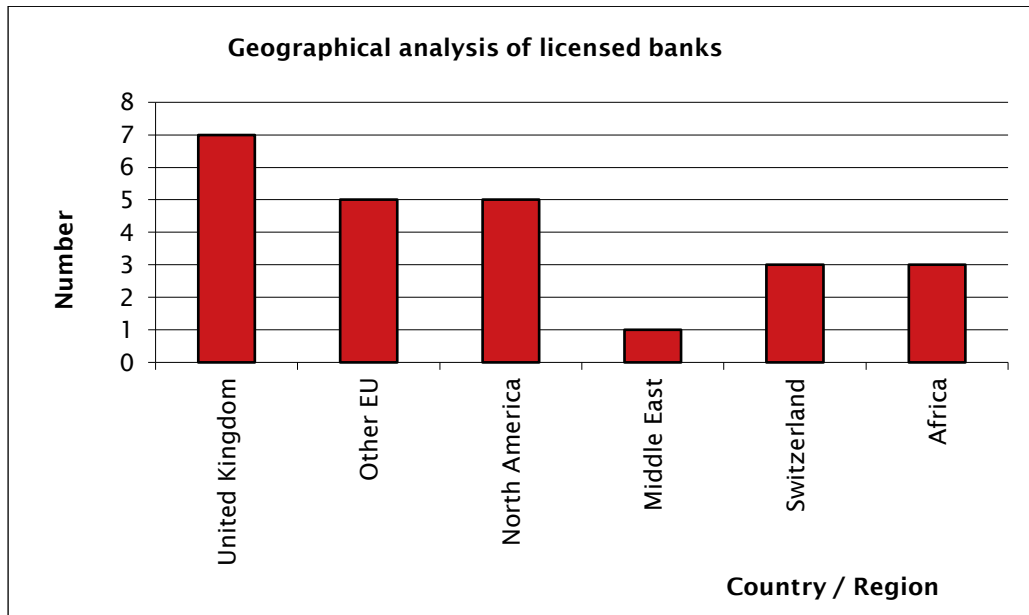
- The number of live companies on the register stood at 33,626 at the end of the fourth quarter of 2020.
- The net asset value of regulated funds under administration increased by £12.6bn from £365.5bn to £378.1bn during Q4 2020.
- The total value of banking deposits held in Jersey decreased from £137.8bn to £131.6bn during Q4 2020.
- The number of banking licences stood at 24 at the end of Q4 2020.
- The total number of regulated collective investment funds decreased from 781 to 750 as at the end of Q4 2020.
- The value of total funds under investment management stood at £28.38bn at the end of Q4 2020. These figures do not include the total assets under management within the qualifying segregated managed accounts (QSMA) which stood at £1.1bn at the end of the quarter.
- As at 31 December, there were 403 JPFs registered and 113 GIMBs registered.

Banks

Registered banks

There were 24 banks registered in Jersey as at 31 December 2020. The geographical analysis of registered banks (based on the jurisdiction of the ultimate parent company) is set out in figure 1.

Bank deposits

Total banking deposits held in Jersey decreased during Q4 2020 from £137.8bn to £131.6bn.

Figure 2 – Analysis of bank deposits as at 31 December 2020¹

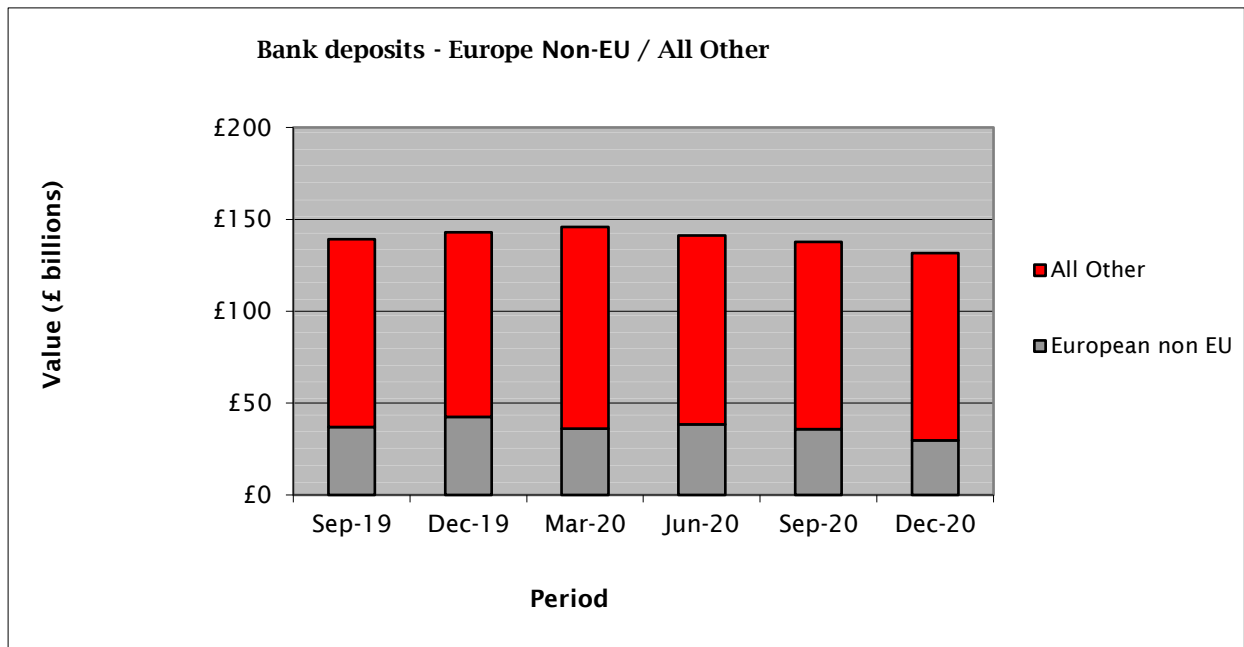
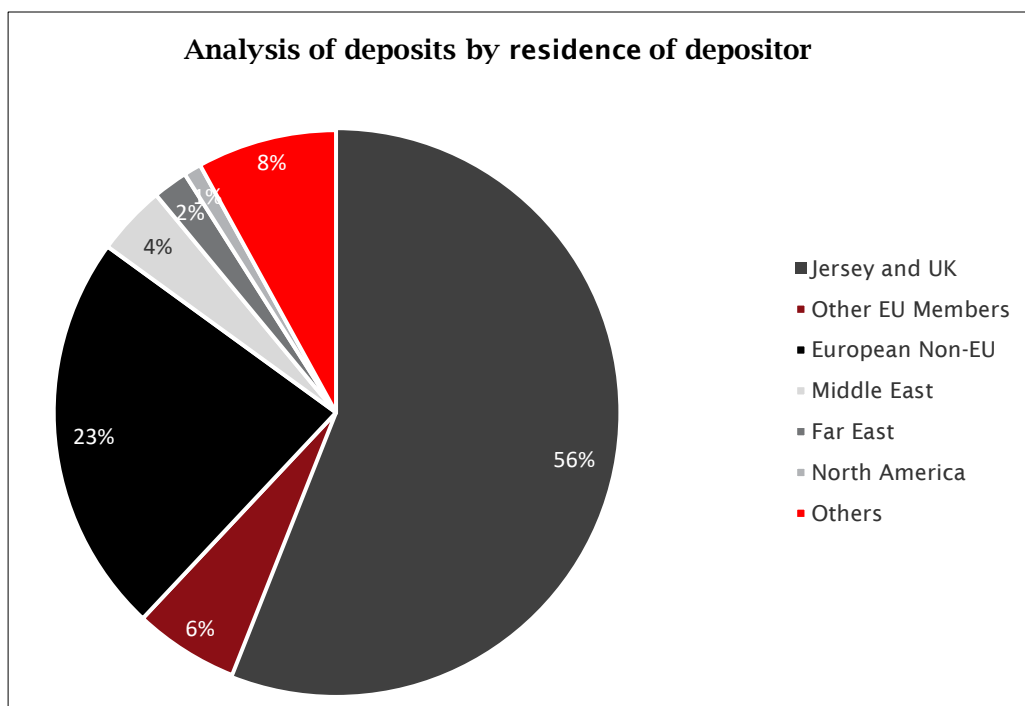


Figure 3 – Deposits by residence of depositors on 31 December 2020



¹ Deposits are analysed between deposits from 'European non-EU Members' and other deposits. The reason for this split is that 'European non-EU Members' includes a significant element of wholesale fiduciary deposits on which margins are much lower than on other types of deposits.

Funds and Fund Management

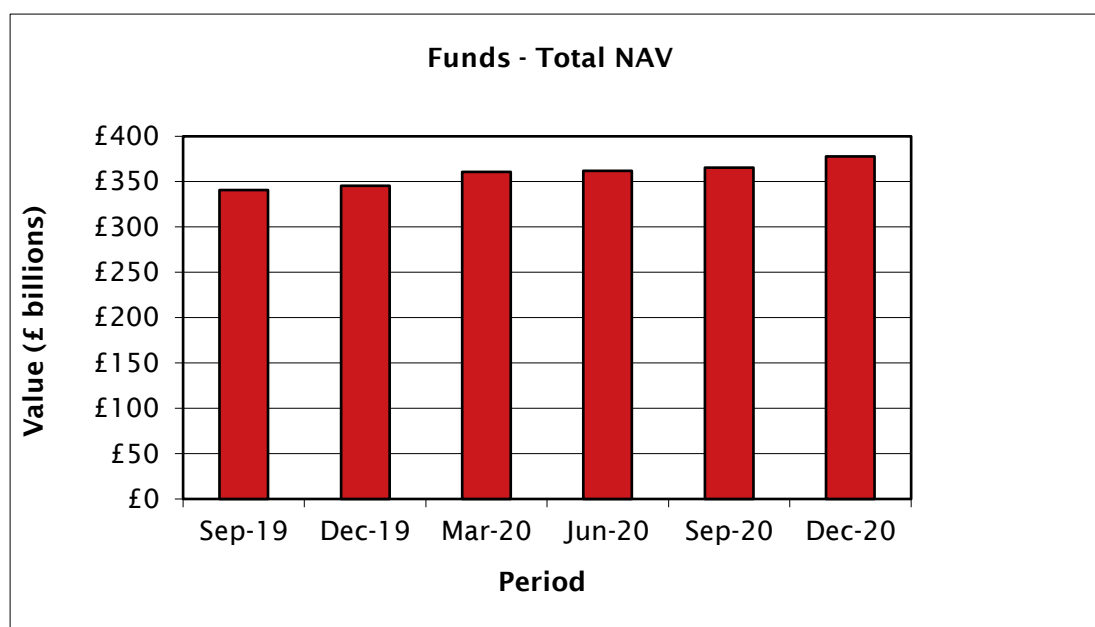
The following data includes both Jersey and non-Jersey domiciled funds administered in Jersey. However, excluded from the analyses are collective investment funds for which the only services provided in Jersey are distribution or similarly minor activities. These funds are regarded as non-Jersey funds for current statistical purposes.

The data also includes funds established under the Control of Borrowing (Jersey) Order 1958 (COBO). COBO funds are private schemes with fewer than 55 offers which do not require a permit under CIF Law, but which do require an initial regulatory consent in the form of a consent granted under COBO.

Key statistics

During the fourth quarter of 2020 the net asset value of regulated funds under administration increased by £12.6bn from £365.5bn to £378.1bn. The total number of regulated collective investment funds decreased by 31 from 781 to 750.

Figure 4 – Net asset value of regulated funds as at 31 December 2020



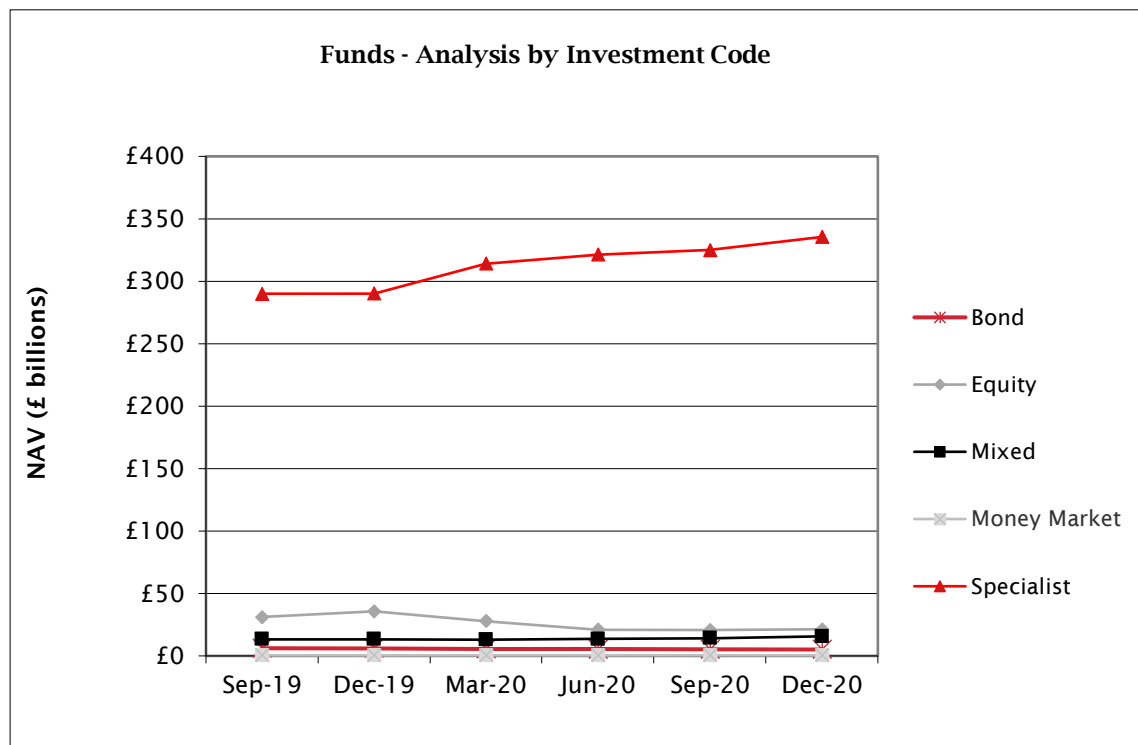
COBO Only Private Placement Funds

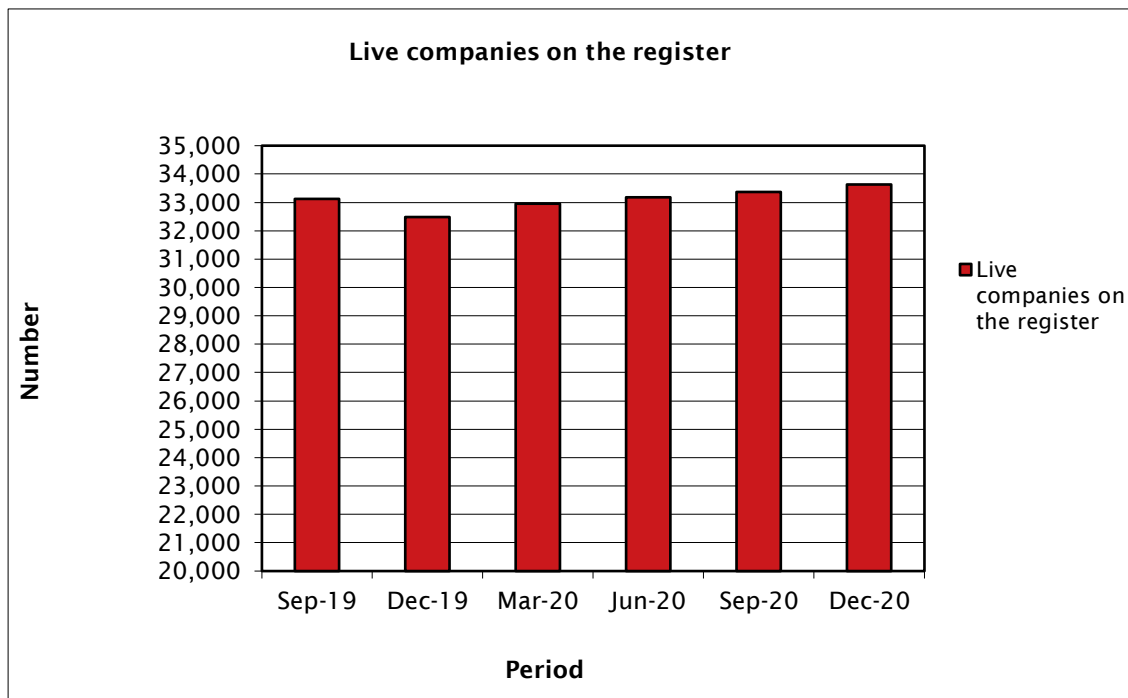
Company incorporations – Jersey companies

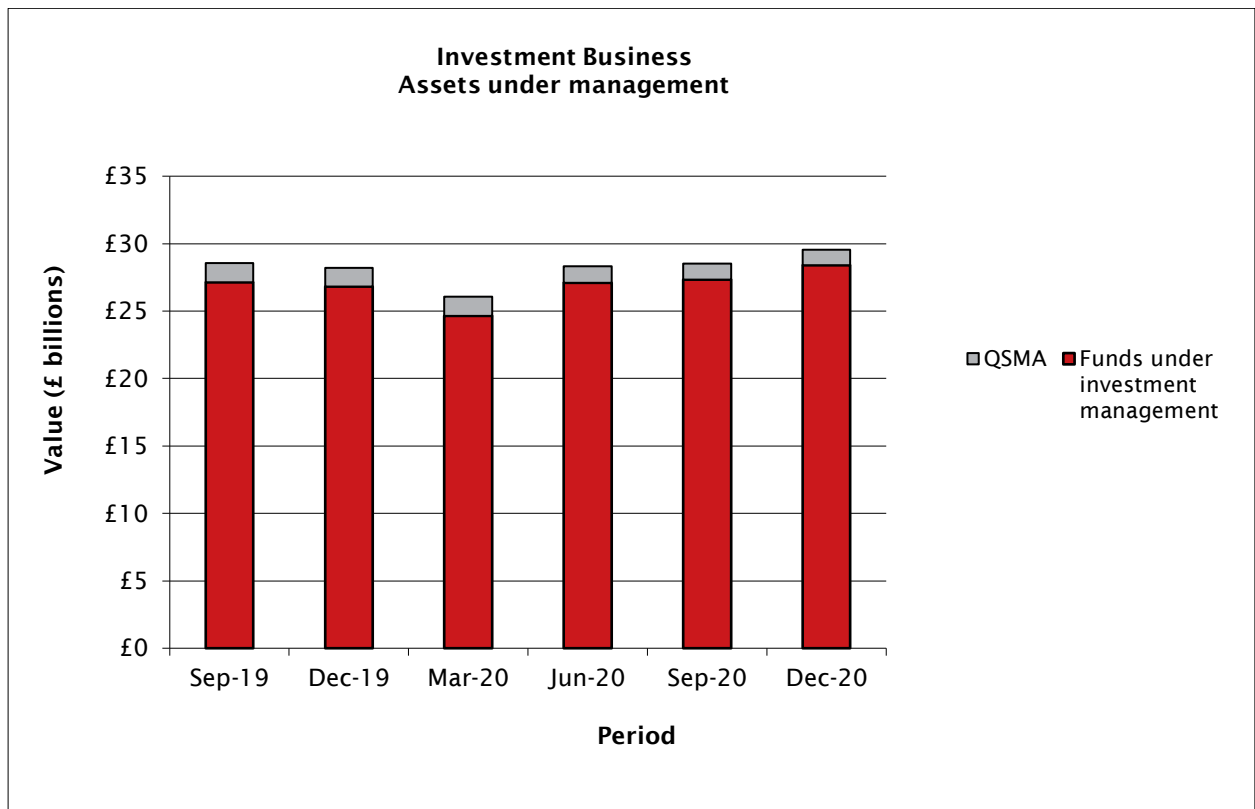
Figure 7 – Live companies on the register as at 31 December 2020
