Financial Services Industry Quarterly Report

Period Ended 31 March 2018



Summary


- The number of live companies on the register stood at 32,125 at the end of the first quarter of 2018.
- The net asset value of regulated funds under administration remain largely flat from £291.1bn to £281.1bn during Q1 2018.
- The total value of banking deposits held in Jersey remain largely flat from £118bn to £115.5bn during Q1 2018. The number of banking licences remained unchanged at 28 at the end of Q1 2018.
- The total number of regulated collective investment funds remain largely flat from 1,104 to 1,075 as at the end of Q1 2018.
- The value of total funds under investment management stood at £22.5bn at the end of Q1 2018. These figures do not include the total assets under management within the qualifying segregated managed accounts (QSMA) which increased by £295m from £1.295bn to £1.590bn at the end of the quarter.
- The above statistics do not take account of the strong uptake in the Jersey Private Fund (JPF) regime, the latest addition to Jersey's suite of fund structuring options, which was launched in April and for which up-to-date statistics are due to be reported at the end of June, together with the statistics for the National Private Placement Regimes (NPPRs).

Banks

Registered banks

There were 28 banks registered in Jersey as at 31 March 2018. The geographical analysis of registered banks (based on the jurisdiction of the ultimate parent company) is set out in figure 1.

Bank deposits





Figure 3 - Deposits by residence of depositors on 31 March 2018

Total banking deposits held in Jersey decreased by £2.5bn during Q1 2018 to £115.5bn. An analysis of the residence of depositors can be found in figures 2 and 3, and in greater detail in Appendix 1.

Figure 2 - Analysis of bank deposits as at 31 March 2018¹

¹ Deposits are analysed between deposits from 'European non-EU Members' and other deposits. The reason for this split is that 'European non-EU Members' includes a significant element of wholesale fiduciary deposits on which margins are much lower than on other types of deposits.

Funds

and Fund Management

The following data includes both Jersey and non-Jersey domiciled funds administered in Jersey. However, excluded from the analyses are collective investment funds for which the only services provided in Jersey are distribution or similarly minor activities. These funds are regarded as non-Jersey funds for current statistical purposes.


The data also includes funds established under the Control of Borrowing (Jersey) Order 1958 (COBO). COBO funds are private schemes with fewer than 51 offers which do not require a permit under CIF Law, but which do require an initial regulatory consent in the form of a consent granted under COBO.

Key statistics

During the first quarter of 2018 the net asset value of regulated funds under administration decreased by £10bn from £291.1bn to £281.1bn. The total number of regulated collective investment funds decreased by 29 from 1,104 to 1,075.



Figure 4 - Net asset value of all funds as at 31 March 2018




COBO Only Private Placement Funds


Company incorporations - Jersey companies

Figure 7 - Live companies on the register as at 31 March 2018


